

Official Rules

Official Rules subject to change in Seer®'s sole discretion.

No purchase is necessary to enter or win. A purchase will not improve the chances of winning.

Submission: Applications will be accepted from September 8, 2025, through October 10, 2025. Submission window closes October 10, 2025, at 5:00PM PST.

Review: Proposals will be reviewed on a rolling basis as proposals are received by a committee of scientific leaders from academia and industry, including members of Seer's Scientific Advisory Board.

Notification: Grant recipients will be notified by October 27, 2025.

Study Execution: Upon agreement signature, grant recipients will be responsible for collection and shipment of biological samples to the designated Seer Technology Access Center (STAC) location by December 12, 2025, according to Seer provided instructions. Seer will oversee the Proteograph processing, LC-MS analysis, and data analysis with turnaround times consistent with STAC service projects.

Prize and Results Presentation: Grant recipients may be invited to present their research findings at Seer's sponsored workshops in 2026. Depending on the nature of the research area granted, Seer may invite grant recipients to present their findings at a conference including, but not limited to, European Proteomics Association (EuPA) Congress 2026, Human Proteome Organization (HUPO) World Congress 2026, American Society for Human Genetics (ASHG) Annual Meeting 2026, or Society for Neuroscience (SfN) Annual Meeting 2026 and pay or reimburse up to USD \$2,000.00 of approved travel expenses supported by receipts. Each grant recipient will receive a cash award of USD \$500.00, and the average retail value of the prize is USD \$500.00. No substitution, assignment or transfer of the prizes is permitted, except by Seer, who has the right to substitute a prize with another of comparable or greater value.

Eligibility Criteria:

To be eligible for consideration, applicants must meet the following criteria:

This proposal is only open to all first-time grant applicants and new Seer customers. Applicants must have attained at least the age of majority in their jurisdiction of residence (entrants must, in any event, be at least 18 years of age). Employees, officers, directors, agents, advisors, representatives and independent contractors of Seer and its subsidiaries or affiliated companies, together with their immediate family members and members of the same households (whether related or not) are not eligible to participate. This contest is only



open to Applicants affiliated with a recognized research institution or organization within the NA and EMEA territories. Applicants who are 1) residents of Cuba, North Korea, Iran, Syria, Russia, Belarus, or the designated Crimea, Donetsk or Luhansk regions of Ukraine, or any territory subject to U.S. embargo or similar restriction; (2) any persons (including businesses, research institutions, government and private organizations, individuals, and other types of legal persons) on the U.S. government's Denied Persons List, Specially Designated Nationals list, Entity List, Unverified List or any other similar list maintained by the U.S. government or any other applicable government, and all individuals employed thereby or otherwise associated therewith; and (3) any persons for whom it would be illegal to participate in or win a 2025 Insights Grant are ineligible. Each giveaway is subject to all applicable laws and regulations, and is void where prohibited or where registration, bonding, or language translation is required.

Research Focus:

The proposed project should align with the capabilities of the Seer Proteograph® Product Suite technology.

Applications will be considered that address translational research areas. One Grant Recipient will be notified by October 27, 2025.

Judging:

This is a contest of skill. Odds of winning depend on the number of participants and quality of the individual entries. Seer may select fewer than one grant recipient if fewer than one eligible application is received. The following judging criterion are equally weighted in determining the winners:

Scientific Merit:

- Demonstrated expertise and track record of the applicant and the Principal Investigator (PI) in the field of proposed research.
- The level of success achieved in past projects led by the PI, as evaluated through the publication record.
- Alignment of the applicant's and Pl's expertise with the goals and requirements of the proposed research, particularly within the framework of the Proteograph workflow.

Impact of Research:

- Contribution to advancing knowledge and translating proteomic insights into solutions for clinically significant challenges across human health.
- Originality of the proposed research approach and methodology.
- Establishing clear avenues for translating research findings into practical applications that can benefit both the business sector and healthcare.



 Potential for resulting publications, presentations, and other communications to disseminate findings to the scientific community and beyond.

Alignment of Seer Technology to Proposed Research:

- Concise clarification of the constraints inherent in current proteomics methodologies that hinder the achievement of the research goals.
- Explanation of how Seer technology improves the quality, efficiency, and depth of investigations.

Experimental Approach:

- Clarity and coherence of the proposed research approach.
- Depth of experimental design and analytical methodologies.
- Feasibility of the work plan, considering resources, timeline, and potential challenges.
- Description of how the Seer Proteomics workflow will be utilized to address research questions.

Entries must be original and not violate any third-party rights, and an Applicant must have all rights and third-party authorizations necessary to submit the entry, including from their research institution or organization. By entering, Applicant represents that their employer policies permit participation and the acceptance of a prize.

By participating, Applicants and Grant Recipients agree to these Official Rules, Seer's STAC Terms and Conditions, and that the determination of each Grant Recipient is final and binding in all respects. Each Grant Recipient must respond to Seer within 14 days of notification attempt. If an Applicant and/or Grant Recipient fails to provide any other reasonably requested information necessary to award the Grant, administer these Official Rules, or comply with applicable laws by the deadline, the Grant will be forfeited and an alternate recipient will be determined, based on the criteria set forth herein.

If selected, Grant Recipients will also have the option to participate and present their scientific findings at a mutually agreeable Seer workshop, contingent upon Seer invitation. Approved travel, hotel accommodations, and conference registration supported by receipts may be reimbursed or paid by Seer up to USD \$2,000.00 in Seer's sole discretion. At Seer's option, all travel arrangements must be made through Seer, or a travel agent designated by Seer. If a Grant Recipient lives within a 200-mile radius of the hotel designated by Seer, air transportation may not be included. Grant Recipients will be responsible for all gratuities, meals, beverages, ground transportation, taxes, and any other incidental costs or expenses not identified in these Official Rules. All tickets and accommodations are subject to the vagaries of schedule variation, weather, work stoppages, and schedule changes.
